Pro Bono Program & Community Engagement



Our representations, which stem from Wiley's pro bono mission to provide equal access to the justice system for individuals and groups who would otherwise be unable to afford counsel, have included noteworthy cases and a diverse array of matters referred through legal service providers with whom we have forged close ties. Some of the outstanding organizations with whom we partner include the D.C. Bar Pro Bono Center, the Legal Aid Society of D.C., and the Washington Lawyers' Committee for Civil Rights and Urban Affairs, among many others. In 2023, our attorneys and legal assistants conducted almost 9,000 hours of pro bono work on nearly 150 matters in numerous forums, including the U.S. Supreme Court.

Highlights of Our Pro Bono Matters:

Wiley Secures Supreme Court Victory in Double Jeopardy Case: In a pro bono victory that also highlights the capabilities of our Issues and Appeals Practice, Wiley persuaded the U.S. Supreme Court to reject, in a unanimous decision, an attempt by the state of Georgia to prosecute a Wiley pro bono client a second time for the same offense. The Court held that federal law, not state law, determines what is an acquittal and that the Double Jeopardy Clause of the Fifth Amendment prohibited Georgia's effort to characterize a jury's verdict of acquittal as something other than an acquittal.

Wiley Secures Victory for Disability Rights Maryland in Pro Bono Lawsuit Against Prince George's County Public Schools: Wiley secured an important victory on behalf of Disability Rights Maryland (DRM) in a lawsuit against Prince George's County Public Schools related to claims of excessive application of inappropriate and exclusionary forms of discipline on students with disabilities. With Wiley's help, DRM was able to secure summary judgment in federal court, which ordered the school district to supply DRM with the parent or guardian contact information for adversely affected students eligible for special education in the district, as part of DRM's investigation into the claims of discriminatory discipline.

Wiley Wins Pro Bono Criminal Case, Securing Dismissal on Behalf of Sudanese Refugee and Professor: Wiley persuaded the U.S. Attorney's Office for the District of Maryland to voluntarily dismiss its case against a Sudanese refugee and prominent microbiology professor. The U.S. government had charged Wiley's client with falsifying documents in response to a government audit of her employer, with the allegations arising from the client's work at the American Islamic Congress. The Wiley team, in partnership with the Public Defender's Office in Maryland, debunked the allegations against the client and the government dropped all charges and dismissed the indictment against Wiley's client.

Wiley Secures Victory for Client in Incarceration Reduction Amendment Act Petition: Wiley successfully petitioned the Superior Court of the District of Columbia on behalf of a pro bono client, who asked the court for a reduced sentence under an extension of the Incarceration Reduction Amendment Act, adopted by the DC Council in 2020. In the April 2023 decision, Wiley's client's IRAA motion was granted, and he was given a reduction in his original life sentence to time served, after serving 28 years for a crime he committed when he was 20 years old.

Wiley Amicus Brief Helps Persuade Fourth Circuit to Reject Obsolete Rule on Attorneys Fees: An amicus brief authored by Wiley's Pro Bono Partner on behalf of 13 nonprofit public interest legal services organizations helped persuade the Fourth Circuit to overturn an obsolete prohibition on certain attorneys' fees awards in civil rights cases. The en banc court's August ruling rejected a long-standing precedent under which a civil rights plaintiff who obtained a preliminary injunction was precluded, as a matter of law, from obtaining an award of attorneys' fees as the "prevailing party" under 42 USC Sec. 1988.

Wiley's Pro Bono Program Achieves 'Significant Result' on Behalf of Immigration Client: Wiley attorneys successfully secured the release of an immigration client from the U.S. Immigration and Customs Enforcement's Alternatives to Detention Program. Alleging that ICE had denied the client procedural due process under the Fifth Amendment, Wiley filed a petition for a writ of habeas corpus on the client's behalf in the U.S. District Court for the Eastern District of Virginia. Wiley was subsequently notified that ICE would be removing the client from its program and would also remove his ankle monitor after three years of electronic surveillance, allowing the case to be dismissed.





Client Successes

In 2023, Wiley attorneys worked on first-of-their-kind, precedentsetting, and complex matters for clients across our practice areas. Here are a few highlights of those achievements.

Government Contracts: Wiley is at the center of some of the largest and most important matters in government contracts, including representing The Boeing Company as intervenor in a successful defense of a \$537 million contract award in a strategically important, partially classified Defense Intelligence Agency procurement for enterprise-wide IT support. The competition was heavily contested by rival bidder CACI, which filed multiple GAO protests. Wiley developed factual and legal responses to CACI's numerous protest grounds – and GAO sided with Boeing and DIA when it denied CACI's protest in March 2023, allowing performance of the new contract award to begin.

Insurance: As the go-to firm for major insurers facing complex and novel legal challenges, Wiley secured a precedent-setting Seventh Circuit victory in a coverage dispute stemming from a \$20 million settlement of a shareholder lawsuit about the price of a corporate merger. The 2023 ruling, in **Joy Global Inc. v. Columbia Casualty Company**, represents the first appellate decision in favor of insurers concerning the applicability of a "bump-up" provision, an issue that is being litigated in several courts across the U.S. Representing the primary insurer in the case, Wiley took the lead role in successfully briefing and arguing the appeal for a tower of insurers.

Intellectual Property: On behalf of generic drug manufacturer Macleods Pharmaceuticals Ltd., Wiley helped persuade a federal court to invalidate a patent for a widely used cardiovascular medication. The U.S. District Court for the District of Delaware ruled that a patent held by Novartis for Entresto, a heart-failure drug that earned billions of dollars worldwide in 2022, was invalid for lacking an adequate written description. The ruling was a victory for Macleods Pharma and two other manufacturers that are seeking to sell generic versions of Entresto.

International Trade: Wiley has one of the largest trade practices in the country, and is working closely with the U.S. government on global negotiations with the European Union and others to write the climate change trade rules for the steel industry for decades to come. Wiley also filed the largest new trade cases of the year on behalf of U.S. aluminum extruders, against 14 countries and affecting billions of dollars in trade. Our team secured a favorable ruling from the International Trade Commission in November 2023, taking the domestic industry a step closer to restoring a level playing field to the U.S. aluminum extrusions market.

Issues and Appeals: Wiley, representing two former SEC Chief Economists as amici, helped persuade the Fifth Circuit to nullify the SEC's new share-repurchase rule in Chamber of Commerce of the United States of America, et al. v. SEC. Finding the SEC rule "arbitrary and capricious" in an October 31 decision, the court agreed with arguments advanced by the petitioners, and by Wiley in an amicus brief authored on behalf of the two economists. The brief, filed in support of the petitioners, argued that the SEC had not provided "any credible support" to justify the rule, which would impose "substantial costs" with "no discernable benefits."

Telecom, Media & Technology: Wiley won a federal lawsuit challenging exorbitant fees imposed by the city of Rochester, NY on 5G small cell and fiber optic facilities in public rights of way (Case No. 6:20-cv-06866). The fees threaten the rollout of broadband infrastructure in the city, and as a result they violate the federal Communications Act and the FCC's implementing regulations. The favorable rulings secured by Wiley in this case are critical to the wireless and broadband industries' ability to quickly deploy new highspeed services to U.S. consumers – and the principles in this case could have a multibillion-dollar impact in jurisdictions across the country.


